Executive Summary

The Economic Development Resident Survey was born out of the Lakeville Economic Development Committee and first was introduced to the town at the 2013 Lakeville Arts & Music festival. At that time, over 50 survey results were obtained through face-to-face interaction with town residents. In January 2014 the survey was distributed by mail with the quarterly tax bill and was made available online to residents. As of the date of this report, there were 654 responses to this survey. Survey questions were generally made as open-ended questions to solicit genuine responses from townspeople. The following report summarizes the results of this survey.

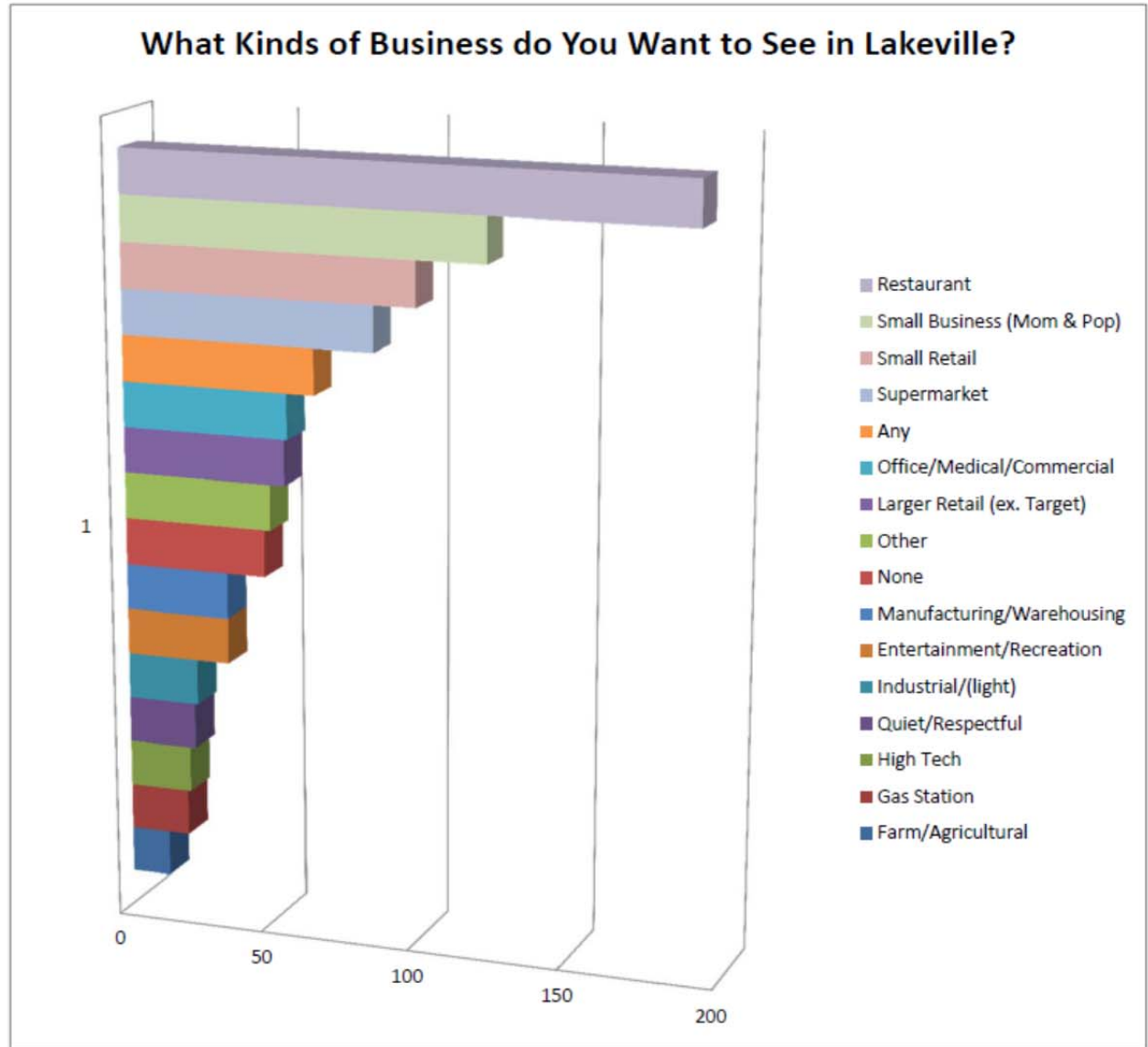
Summarization of Data Process

The Economic Development Resident Survey contained 6 questions. Questions 1, 2, and 4 were open-ended response questions, while questions 3, 5, and 6 allowed for additional comments. For questions 1 and 2, survey responses were summarized into categories which contained similar expressions or sentiment which was done at the discretion of the survey compiler. Every effort was made to ensure that responses were categorized appropriately; however, as the survey compiler is human, errors may have been made. Detailed data responses behind the categorization are available upon request.

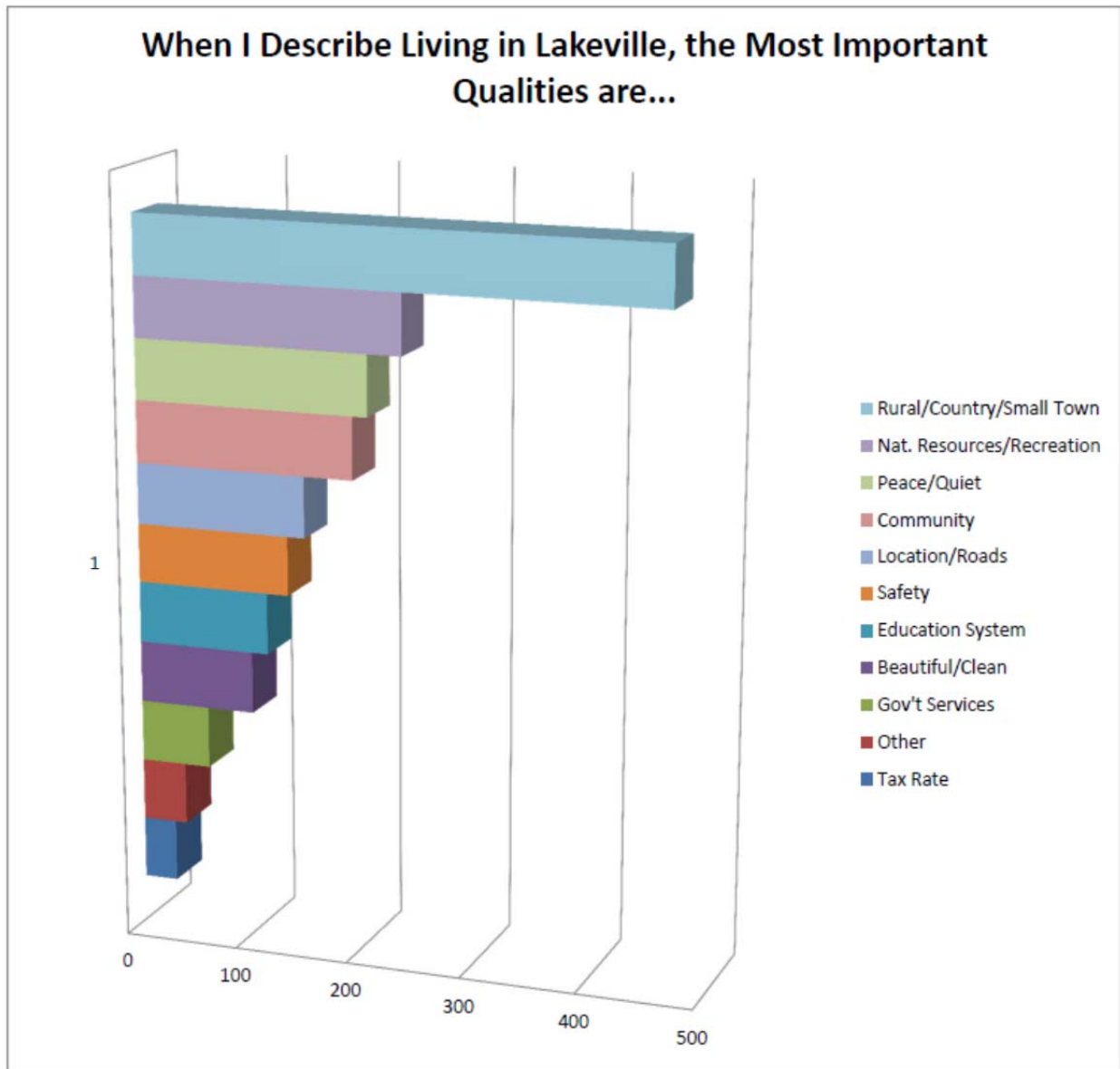

Question 1

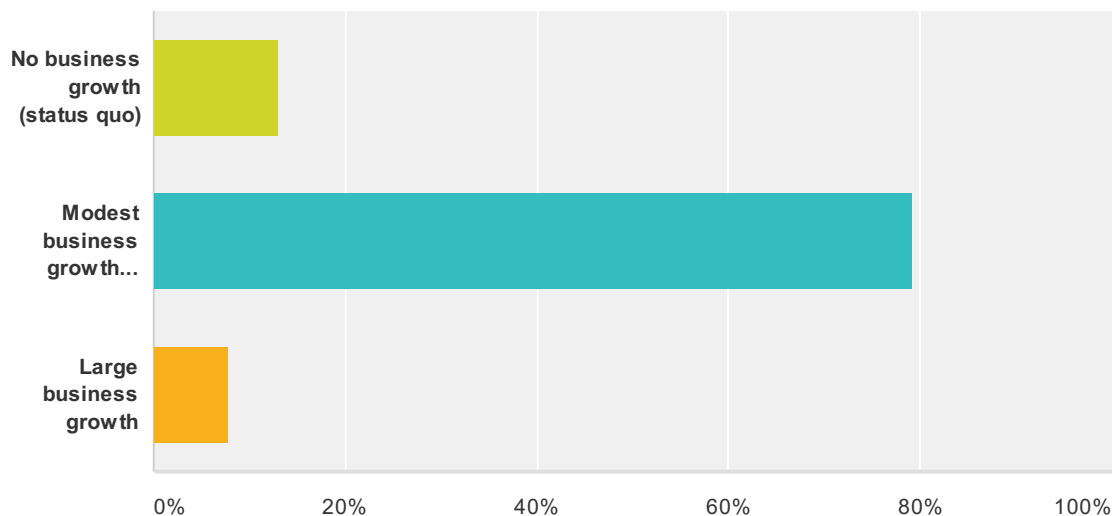

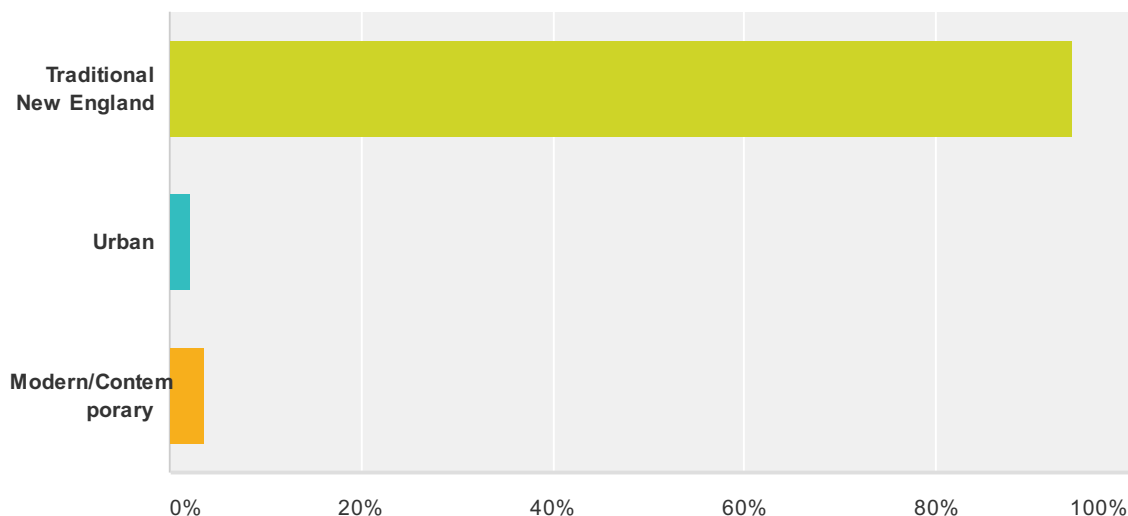

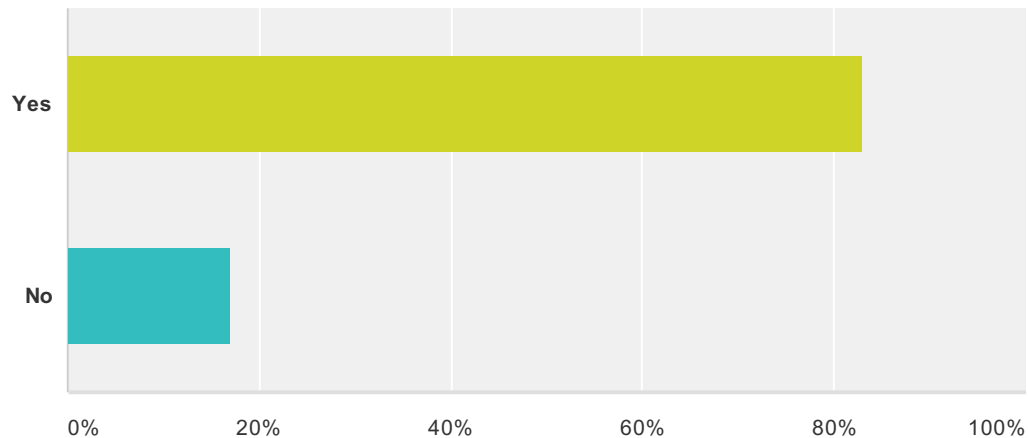
