Retail only: \$100 per 5000 Sq. ft. (minimum \$100 if under 5000 sq. ft.)
Mobile & Catering: \$150
Residential Kitchen: \$150
Temporary (retail only): \$25 daily
Temporary (food prep limited to hot dog steamer, popcorn): \$50 daily
Temporary (larger scale-fairs, multiple food vendors): \$75 daily, per vendor (Not to exceed 1 week)
Common Victualler License: \$25
Milk & Cream License (Dealer) Valid 5 Yrs: \$10
Milk & Cream License (Store & Mobile): \$10
Restaurant Re-Inspection: \$50-2 <sup>nd</sup> / \$100-3 <sup>rd</sup> / \$200-4 <sup>th</sup>
